AGIO:


One-off 5% agio on your investment to cover the cost of contracts, notary public, company register and set-up.

No monthly maintenance fee. The resort will take care of all buildings, maintenance fees are part of the resort's running costs.




JUNIOR SHARE – US\$ 350,000 Single Wooden House








DELUXE ROOM – US\$ 280,000 In a DELUXE Bungalow
